

## **Data Processing Notice** **related to the HUPX - ARGUS Guarantees of Origin Workshop - Shades of Green in Energy Trading**

**HUPX Hungarian Power Exchange Company Limited by Shares** (registered office: 1134 Budapest, Dévai u. 26-28, company registration number: 01-10-045666, tax number: 13967808-2-41, contact: [info@hupx.hu](mailto:info@hupx.hu), hereinafter as: “**Data Controller**”) shall describe the data processing actions implemented in relation to the HUPX - ARGUS Guarantees of Origin Workshop - Shades of Green in Energy Trading online workshop to be held on 11<sup>th</sup> April 2022 in Microsoft Teams Webinar environment (“**Workshop**”) in this Data Processing Notice (hereinafter as: “**Data Processing Notice**”).

<b>Scope of processed data</b>	Participant's name, position, company, country, e-mail address
<b>Scope of data subjects</b>	Persons registering for the Workshop
<b>Legal basis of processing</b>	Consent from the data subject as per Article 6(1)(a) of the GDPR.
<b>Time limit for data storage</b>	Until the consent of the data subject is withdrawn.
<b>Method of data processing</b>	Electronically.
<b>Source of the data</b>	Data collected from the data subject.
<b>Possible consequences of failure to provide the data</b>	The provision of personal data shall be a precondition of the registration, therefore if the data subject fails to provide the data to the Data Controller, the Data Controller will not be able to conduct the selection process in terms of the data subject.

<b>Time limit for data storage</b>	Until the consent of the data subject is withdrawn. Possible withdrawal does not affect the previous legal ground of data processing.
<b>Method of data processing</b>	Electronically.
<b>Source of the data</b>	Data collected from the data subject.
<b>Possible consequences of failure to provide the data</b>	Initials, abbreviations or false names may be used instead of full/real name on the screen. However, questions or other active contribution may only take place after the consent of the data subject to the data processing.
<b>Automated decision-making and profiling</b>	The Data Controller does not perform any automated decision-making or profiling.
<b>Who can access the personal data?</b>	The Data Controller's competent co-workers.
<b>Data transfer to third countries or to international organisations</b>	No data are transferred to third countries or to international organisations.
